SELECTION PROCESS AT BODHI FOUNDATION INDIA

Evaluation of Nomination for the "Sustinere Green Global Awards" is an intensive process. Nomination will be evaluated by eminent personalities derived from Government, public sector, private sector, media, and academic institutions who have wide experience in the areas related to the award. To guarantee that all nominations are carefully screened and verified priors to the jury selections of winners, the evaluations process will take the course over five levels, and will be conducted by independent, yet cooperative bodies.

- Application in the given format Submission of duly filed forms along with presentation
- Validation of Received Forms
- Short listing of applicants for the jury presentation
- Eminent jury to do the screening and Selection of the winners /site Visit if required/jury visit to select units/workplaces/properties.
- Award ceremony

- **Large Enterprise**
(Organizations with annual turnover of more than 750 crores)
- **Medium Enterprise**
(Organizations with annual turnover of Between 250 crores but More than 750 crores)
- **Small Scale Enterprise**
(Organizations with annual turnover of more than 5 Cr but less than 250 crores)
